



PEACH PAYMENTS PRIVACY POLICY

Updated July 2026

1. INTRODUCTION

This Privacy Policy ("**Policy**") explains how Peach Payments ("**we**", "**our**" or "**us**"), as the responsible party in terms of the Protection of Personal Information Act, 2013 ("**POPIA**"), collect, store, use, and disclose your business and personal information. This Policy applies to information collected through our website www.peachpayments.com as well as through our services provided to merchants.

We are committed to protecting your privacy and safeguarding your personal information, regardless of where you access or use our services.

By using our website or services, including when making a payment via Peach Payments, you agree to the collection and use of your information in accordance with this Policy. We process your personal information on one or more lawful grounds under applicable law, including where necessary to perform a contract, comply with a legal obligation, or where we have a legitimate interest in doing so. If you are a merchant, this policy complements your contractual agreement with us, and the collection of your customers' personal information will be governed by that agreement. This Policy also applies to individuals making payments to merchants using Peach Payments' services ("**customers**"). By completing a transaction through Peach Payments, you, as a customer, consent to the collection, use, and disclosure of your personal information as outlined in this Policy.

This Policy does not apply to third-party websites, products, or services, even if they are linked from or to our website. Please review the privacy policies of third parties separately.

We may update this Policy from time to time. We will post any changes on this page, and they will be effective immediately upon publication. Your continued use of our website and services indicates your acceptance of any changes.

2. INFORMATION WE COLLECT

We collect personal information directly from you in several ways:

From Merchants or Visitors

- When you register as a merchant or contact us for information about our services, we collect information such as your name, contact details, business details, and other information necessary for providing our services.
- If you participate in promotions, surveys, or submit content via our website, we may collect additional personal details you provide.



From Payers

When you make payments using Peach Payments services, we collect necessary information to process transactions, including payment card details, billing address, and contact details.

Automatically Collected Information

We use cookies and other tracking technologies to collect information about your interactions with our website and services. This includes details about your device, browser type, IP address, and page visits. You can control cookie storage in your browser settings.

3. HOW WE USE YOUR PERSONAL INFORMATION

We use your personal information for several purposes, including:

- to provide our products and services, including processing payments and managing merchant accounts.
- To communicate with you about our services, promotions, and updates, unless you opt-out of marketing communications.
- To comply with legal and regulatory obligations, such as Know Your Customer (KYC) requirements and fraud prevention.
- To improve our website and services by analyzing usage patterns and preferences.
- To personalize our offerings and ensure the security of transactions.

4. DISCLOSURE OF PERSONAL INFORMATION

We may share your personal information with the following parties:

- **Affiliates and Service Providers:** We may share information with companies that help us with operations like website hosting, payment processing, fraud detection, and customer support.
- **Legal Requirements:** We may disclose personal information if required by law, such as in response to a subpoena or court order, or to protect against fraud or illegal activity.
- **Business Transactions:** In the event of a business transfer (e.g., merger or acquisition), personal information may be shared as part of the transaction.
- **Third Parties with Consent:** We may share your information with your consent or as directed by you.

5. INTERNATIONAL TRANSFERS OF YOUR PERSONAL INFORMATION

Our services may involve transferring personal information to locations outside your country. These locations may have different data protection laws. We will ensure that any such transfers comply with applicable data protection legislation, including section 72 of POPIA, by implementing appropriate safeguards such as binding agreements with recipients, ensuring that



the recipient country has adequate data protection laws, or obtaining your consent where required.

6. DATA SECURITY

We implement industry-standard security measures to protect your personal information. This includes using firewalls, encryption, and secure access protocols. However, it is important that you keep your account credentials secure, as we are not responsible for unauthorized access resulting from your failure to protect your login details.

7. RETENTION OF PERSONAL INFORMATION

We retain personal information only for as long as necessary to fulfil the purposes outlined in this Policy, including any legal or regulatory obligations. After this period, we securely delete or anonymize the information.

8. YOUR RIGHTS AND CHOICES

Depending on the applicable laws in your jurisdiction, you may have the following rights regarding your personal information:

- **Access:** You may request access to the personal information we hold about you.
- **Rectification:** You can request corrections to any inaccurate or incomplete information.
- **Deletion:** You may request the deletion of your personal information in certain cases, though we may retain information for legal or business purposes.
- **Opt-Out:** You can opt out of marketing communications at any time.
- **Withdraw Consent:** If you provided consent for specific uses of your information, you can withdraw it at any time.

For merchants' customers, data rights requests should be directed to the merchant, who can coordinate with us if necessary.

9. CHILDREN'S PRIVACY

Our services are not directed at children, and we do not knowingly collect personal information from anyone under 18. If you believe we have unintentionally collected information from a child, please contact us, and we will promptly delete it.
